Privacy Policy

1. We respect your privacy

- 1.1. URT Ultimate Results Training respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the National Privacy Principles established by the *Privacy Act* 1988 (Cth). This policy sets out how we collect and treat your personal information.

2. Collection of personal information
